## Minutes of the Council meeting hold in Budapest, August 26, 2004

The President opened the meeting at noon.

### 1. President's address

The President welcomed the ESRB council members present at the Annual Meeting and emphasized the high numbers of attendants. He thanked and congratulated the local organizers, and especially G. SAFRANY, for the excellent organization of the 33th meeting in Budapest.

He mentioned that he represented ESRB at the COSPAR meeting in Paris, July 2004.

### 2. Approval of the agenda

The agenda was approved.

### 3. Minutes of the Council meeting, Bisbane, August 18, 2003.

The Minutes of the last meeting were approved without any changes.

### 4. Composition of the Council

Several members of the Council had to be replaced either because they are at the end of their term (W. DÖRR, M. HOFER, M. MARTIN, SERVOMAA) or because of resignation (C. DESAINTE).

The Council will propose to the General Assembly to replace them as follows :

The President will be G. GROSSI (Italy) and the de Vice-President G. SAFRANY for the period 2005-2006.

5. Proposal to change the name of the Society : European Radiation Research Society instead European Society for Radiation Biology  
The President had organized a ballot by mail.  
A total of 27 members out of 31 replies approved the change of the Society name.  
Since the by law of ESRB imposes that 2/3 of members must be present to decide any change of the by law, such as the Society name, and since less than 30 members of the Society out of 118, are present, no decision could be taken. The proposal will be submitted to the General Assembly in 2005 : this second General Assembly will be allowed to decide whatever the number of members present will be.
6. Cooperation with national Societies for Radiation Research.  
The President mentions that the German, Italian and Ukrainian Societies have contracted a agreement with ESRB; these national Societies will diffuse the information on ESRB activities and encourage their members to become ESRB members. The membership fee to ESRB will be reduced to 15 €per year.  
The French and the Swedish Societies seem to be interested in such a cooperation contract.
7. Bacq and Alexander Award  
The laureate for 2004 is A.T. NATARAJAN from Leiden. He will give the Bacq and Alexander lecture on Friday the 27<sup>th</sup> at 11.15 am.  
There will be another Bacq and Alexander Award in 2005.  
As usual, the Secretary-Treasurer will contact the Council members for nominations by the end of this year.
8. Young Scientist Awards and Young Scientist Travel Awards :  
Two Awards of 750 €each are offered to Stephen S.MOORE (United Kingdom) and Pavla NOVAKOVA (Germany) and eight travel awards of 500 €to :

9. Report of the Secretary-Treasurer :
